Desired Qualifications and Experience for the post of Vice-Chancellor

Qualifications and Experience

1. Post graduate degree in Medical/Allied Health Sciences or doctorate in any other faculty with good academic record.
2. Person of the highest level of competence, integrity, morals and institutional commitment is to be appointed as Vice-Chancellor. The Vice-Chancellor to be appointed should be a distinguished academician, with a minimum of ten years of experience as Professor in a University system or ten years of experience in an equivalent position in a reputed research and/or academic administrative organization.
3. Shall have research publications in peer-reviewed journals.
4. Execution of research projects.
5. Experience of working with international bodies or international exposure through participation in workshops, seminars or conferences held outside the country.
6. Experience of organizing events such as workshops, seminars, conferences at an International / National level within the country in the field of higher education.
7. Leadership Skills.
8. Experience of working in Board of Management, Academic Council and other statutory authorities of University.
9. Knowledge of assessment and accreditation procedures.
10. Interpersonal communications and collaborative skills.
