Stray Vacancy Round – 11<sup>th</sup> Jan. 2021 from 10.00 am onwards.

As per the Order dated 28/08/2017 of Hon’ble Supreme Court of India in SLP to appeal (C) No. (s) 30336/2016, W.P. No 267/2013, I.A. No 78432/2017 in W.P.(c) No.76/2017 and other batch of applications, and as per the counseling schedule published by DGHS/MCC on their website, admission to the vacancies, after the Stray Vacancy round of MCC/DGHS, for undergraduate courses in Dental (BDS) for academic year 2020-21 in Krishna Institute of Medical Sciences (Deemed to be University) will be done on the basis of inter-se merit of the students whose names are published by MCC/DGHS on their website.

For vacancies under NRI category, preference shall be given to candidates who fulfill eligibility criteria for NRI quota as per the order of the Hon’ble Supreme Court of India dated 22/08/2017 in WP (C) 689/2017.

Candidates who desire to take admission in Krishna Institute of Medical Sciences (Deemed to be University) against the vacancies should apply to the Deemed University.

Candidates who registered their names with KIMSDU may personally present on 11<sup>th</sup> Jan. 2021 for Stray Vacancy Round counseling. The selection will be done on the basis of merit of candidates who registered their names with KIMSDU and reported for counseling.
